

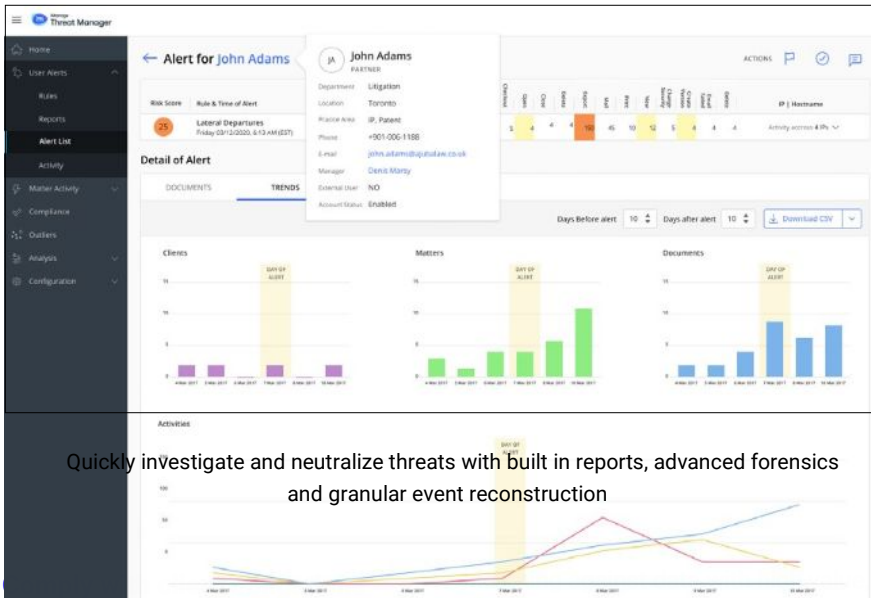
Modern information security and governance controls
